Pre-Registration Info for 2022-2023

Classes are available for children ages 18 months through Pre-K***

Tuesday, Wednesday, & Thursday

9:00 am – 2:00 pm

*****Extended Care is available 8:00 am - 3:00 pm*****

Choose the 3-day (T, W, Th) or the 3-day with **Extended Care** option.

Meet the Teacher will be Wednesday, 8-17-22 at 10:00a. Our first day will be Thursday, August 18, 2022, and will end on Thursday, May 18, 2023.

We follow the LPISD school calendar for holidays and closings.

FP Regular and Extended Care will release at 11:00 am on LPISD Early Release days, if applicable.

***Non-Refundable* Registration Fee due at time of enrollment:**

Early Registration Fee (on or before April 28, 2022) = \$100.00 each child

Registration Fee (on or after April 29, 2022) = \$150.00 each child

Toddler Class (18-23 months old)**	\$275 per month	Not available	\$35 annual <u>Due w/ August's or 1st mo. tuition</u>

AUGUST'S REGULAR TUITION WILL BE \$137.50 (Prorated) Extended Care Tuition will be \$175.00

***Threes and Pre-K students must be completely potty trained.**

**Must turn of age by September 1, 2022. We follow the LPISD age placement policy.

***All classes & extended care must have a minimum number of participants to offer classes/services

Medical and Health Requirements:

A copy of your child's up-to-date immunization record is required as well as a signed/dated Health Care Professional's statement of your child's ability to participate in our program. Please include a signed (by doctor and parent) Food Allergy Emergency Plan, if this applies to your child. The Admission Form in the Registration Packet has a place for your doctor's signature (p. 2) or you may present a separate written statement on letterhead from your healthcare provider. Vision and Hearing Screening is required for our Pre-K class only and the fee is included in the supply fee.

In order to register your child, simply complete the attached 1-page Pre-Registration Request Form and turn it into the FP office along with the Registration Fee (this secures your child's spot). The 4-page Registration Packet is **due on or before August 1, 2022**. This gives parents most of the summer to get all the needed information, signatures and doctor visits for a properly completed form. Parent Handbooks will be passed out at "Meet the Teacher", which takes place from 10:00 to 11:00 am, on Wednesday, 8-17-22. Otherwise, handbooks will be given upon receipt of the 4-page registration packet.

Before submitting your completed packet-check to ensure you have all the proper documents and fees:

- ___ Registration Fee of \$100 (non-refundable unless class does not make and due with Pre-Registration form to hold spot) if enrolled by 4/28/2022. Registration fee **increases to \$150 on Friday, 4-29-2022**. **If paying in cash, please have exact change.**
- ___ Completed 1-page Pre-Registration form (basic info to begin enrollment).

LATER (due by Monday, August 1, 2022)

- ___ Completed 4-page Registration Packet with appropriate signatures, addresses and phone numbers.
- ___ Completed and signed Healthcare Provider's Statement, Food Allergy Emergency Plan, if applicable (for **doctor diagnosed** food allergies only). **Parents, please schedule your child's doctor appointments as soon as possible, in order to have everything ready by August 1, 2022.**
- ___ Current immunization record (must be up-to-date according to the Texas Department of State Health Services standards).
- ___ Sign up for REMIND app (required) and PayPal (if applicable).
