## **WHAT TO BRING TO CAMP**

- Bible / Notebook / Pen
- Day-to-Day Attire (comfortable clothes for during the day, casual clothes for evenings, activewear for Fuego Fun & Late Night Rec if you think you'll need them)
- Tailgate Attire (sports team jersey, face paint, foam fingers, team hat, etc.)
- Variety Show Attire (anything Christmas- tacky sweaters, Santa hats, Christmas costume, etc. - There will be a "Best Dressed" Contest!)
- FueGLOW Attire (anything that will show up under backlights & that you'll be comfortable being active in- white/neon clothing, glow sticks, anything that lights up, etc.)
- Paint War Attire (anything you're okay with getting covered in paint... cheap shoes, shower caps, & swim goggles are helpful! Most like to wear a white shirt to bring home as a souvenir.)
- Shoes (casual shoes, shoes for rec, shower shoes, etc.)
- Swimsuit (t-shirt required over swim wear for both guys and girls) & beach towel
- Pajamas
- Plastic Bag for wet clothes, etc.
- Toiletries (toothbrush, deodorant, shampoo, soap, bath towel, etc.)
- Pillow, sheets (twin size) or sleeping bag
- Sunscreen & bug spray
- Flashlight
- Wristwatch
- Reusable water bottle
- Snacks & snack money
- **There is no need to bring:**
- Any clothing that goes against the dress code.
- Firearms, weapons, etc.
- Alcohol, tobacco, etc.
- Your cell phone (take a break and focus on The Focus)

**Dress code:**

Students and adult sponsors, please do not to pack anything that:

- Advertises alcohol, tobacco, illegal drugs
- Explicitly or implicitly promotes racism, sexism, or hatred of any group or person
- Explicitly or implicitly refers to sexual actions or situations
- Is excessively short or tight fitting (Avoid "Cheer" Shorts, "Booty Billboards," etc.)

**While at camp, we ask that students and adults:**

- Wear closed-toed shoes to rec.
- Wear a T-Shirt over swimwear at the pool (both guys and girls)
- Wear modest shorts or jeans for worship
- Do not dress in a way that calls attention to their underwear (sagging your pants, rolling down your waistbands, etc.)
- Wear a dark T-Shirt if you plan to take the messy games or water games. (We use a lot of water...it's Louisiana and its summer)

**Medications:** If your student has medication, please put everything in a zip lock bag with instructions. The medication will be kept in the room in a locked box so that only the adults have access when necessary.

**Cell Phones:** Your student will not be allowed to use their cell phone during camp. If they need to make a call, an adult chaperon will have a phone or they can use a camp phone. Please do not bring your student with a cell phone.

**Assumptions of Risk.** I am aware of the risks associated with participation in the above event and do hereby voluntarily assume full responsibility for any risk of loss, property damage or personal injury, including death, that may result from participation in event activities.

**Medical Emergency.** In the event of injury or a medical emergency, I understand that the church's group leader, not Camp Fuego, Camp Bethany, and/or Acadian Baptist Center, will be responsible for the medical care of all attendees. It will be the church group leader's responsibility to assess medical needs, obtain and consent to appropriate medical care, transport persons in need of medical care and contact parents or guardians of minors. I release Camp Fuego and Camp Bethany from any and all liability related to medical treatment. In addition, I assume the risk and financial responsibility for any injury resulting from the attendee's participation in all Camp Fuego, Camp Bethany, and/or Acadian Baptist Center events.

**Facility Recreation Addendum** -The recreation programs at Camp Bethany and Acadian Baptist Center strive to offer fun, safe, and challenging activities that engage the whole person-body, mind and soul. Facility staffs are trained and, as a team, committed to your rewarding experience with safety as their highest priority. They have done everything possible to mitigate any risks involved in their recreation programs, however there are inherent risks to participation in recreation activities, including but not limited to, initiative games, high and low challenge course, outdoor education, paintball and aquatics. You could experience any of the following -elevated heart and respiratory rates, uncomfortable group dynamics, climbing or descending unpredictable and possibly slick or uneven terrain, crossing narrow wires and logs, jumping, running, climbing/descending steep rock faces, traveling long distances in remote settings, carrying weight on your backs and shoulders, unforeseen forces of nature or weather, any of which could result in injury/illness that could result in loss of life, limb, and/or property. You are also agreeing that you or your child will NOT ENTER any pool, pond or lake, if they have not received certified swim training, prior to attending camp. This training is not available at the facility.
